10. Time and date of opening of financial bids will be informed to the qualified bidders.
11. Bidders shall have valid class II / III Digital Signature Certificate (DSC) obtained from any certifying Authorities.
12. The scope of services is provided in the Terms of Reference (TOR). All information contained in this proposal should be treated as commercially confidential and you are required to limit dissemination on a need-to-know basis
13. It is to be noted by all the bidders that while all the information and data regarding this RFP is, to the best of the Client's knowledge, accurate within the considerations of scoping the proposed contract, the Client holds no responsibility for the accuracy of this information and it is the responsibility of the bidder to check the validity of data included in this document
14. Bidders are advised that the selection of Agency shall be on the Quality cum Cost Basis Selection (80:20 weightage) basis by the Authority. The details of the Selection Process are specified in this RFP. Applicants shall be deemed to have understood and agreed that no explanation or justification for any aspect of the Selection Process shall be given and that the Authority's decisions are without any right of appeal whatsoever
15. Proposals shall be evaluated on Quality cum Cost Basis Selection i.e. 80% weightage to Technical Proposal on Quality Based Selection and 20% weightage to Financial bid. MSRDC shall evaluate the financial bid of those firms who shall be declared technically qualified by qualifying marks of not less than 80 as enumerated in Evaluation Table. The Quality and Cost basis Selection (hereinafter called QCBS) Method shall be followed for selection of the bidder
